

# **Election Notice**

Notice is hereby given that from

**30.05. – 03.06.2022**

the

**election**

for the

**49th Student Parliament**

and the

**Student Councils**

of the University of Siegen will take place.

## **1. Period of Voting**

The elections will take place in the period from 10:00 am – 3:00 pm<sup>1</sup>.

## **2. Location of voting**

The elections will take place at following locations:

### **A) Building Adolf-Reichwein-Straße:**

## **3. Right to vote and eligibility**

### **a) For the Student Parliament**

I. All members of the student body of the University of Siegen who have been enrolled since April 24, 2022 and are listed in the register of voters are eligible to vote and to be elected. Anyone who is duly enrolled is a member of the student body.

II. Guest and secondary students are neither eligible to vote nor to be elected.

III. Students on leave of absence are eligible to vote and to be elected

### **b) Für die Fachschaftsräte**

I. All members of the student body of the University of Siegen in the corresponding elective subject area who have been enrolled since April 24, 2022 and are listed in the register of electors are eligible to vote and to be elected in their respective subject council. Anyone who is duly enrolled is a member of the student body.

II. Guest and secondary students are neither eligible to vote nor to be elected.

III. Students on leave of absence are eligible to vote and to be elected.

## **4. Election proposals**

### **a) For the Student Parliament**

I. Election proposals must be submitted to the Election Committee in digital form by May 9, 2022. The Election Committee will provide forms for this purpose on the AStA homepage. Handwritten election proposals are not permitted.

- II. The election proposal shall include the name of the list, contact details of the person responsible, name, matriculation number and faculty of the candidate as well as the name of the body to be elected.
- III. The nomination must be accompanied by a written declaration of consent and the full address of the candidate, including e-mail address and telephone number.

b) For the Student Councils

- I. Election proposals must be submitted to the Election Committee in digital form by May 9, 2022. The Election Committee will provide forms for this purpose on the AStA homepage. Handwritten election proposals are not permitted.
- II. The election proposal shall include the name of the list, contact details of the person responsible, name, matriculation number and department of the candidate as well as the name of the body to be elected.
- III. The election proposal must be accompanied by a written declaration of consent and the full address of the candidate, including e-mail address and telephone number.

Objections against errors within the election proposals can be lodged with the election management until May 23, 2022. The objection must be made in writing by e-mail.

## **5. Number of Members to be elected**

- a) The Student Parliament has 25 members.
- b) If the respective student council constitution does not stipulate a different number, the number of mandates to be awarded shall be seven.

## **6. Election system**

a) For the Student Parliament

- I. For the election, the entire student body of the University of Siegen forms a constituency.
- II. Each voter has a total of three votes, which can be distributed among the lists themselves or among candidates from different lists.
- III. Cumulation of votes is permissible.
- IV. Each voter has the possibility of abstention.

b) For the Student Councils

- I. For the election, each student council forms a constituency.
- II. Foreign students taking part in the German course or Studienkolleg vote in their respective constituency.
- III. Each voter has one vote.
- IV. Each voter has the possibility to abstain from voting.

## **7. Register of Voters**

Information about the entry in the list of voters can be obtained from April 30, 2022 at the Asta office at the time of its opening hours.

Objections against errors in the list of voters can be lodged with the election management until May 9, 2022. The objection must be made in writing by e-mail. The Election Committee will decide on this by May 14, 2022.

## **8. Postal Vote**

The possibility of postal vote exists.

Postal vote has to be applied for no later than May 27, 2022, in writing by means of a personally signed document or in person at the election administration. To apply for the postal vote, the student ID card must be presented

It is enough if the necessary documents are send in by E-Mail at [wahlausschuss@uni-siegen.de](mailto:wahlausschuss@uni-siegen.de).

The postal vote documents will then be sent to the voter, but can also be picked up in person. The postal vote documents must be received by the election administration by the last day of the election June 3, 2022 at 3:00 p.m.
