All required documents must be submitted **copy**. Only complete applications can and as will be processed.

Following documents have to be submitted by all applicants (every semester!) :

- matriculation certificate with number of semesters
- Health insurance contributions (how much you pay for health insurance)
- Rental contract
- **6 months** of bank statements **for all of your accounts**
- Birth certificate/s of your child/children (if you have children)
- Proof of child benefit (if you have children)
- 6 months of bank statements for partner's account, if you're living in a shared household

Students with handicap have to submit the following documents only (according to § 2 Abs. 2 Satz 1 HärtefO):

- Complete identity card for disabled person
- matriculation certificate with number of semesters
- Copy of your USI-Card

General information concerning the application:

You have the possibility to apply for refunding of part the semester fee. This part contains the cost for the public transportation ticket in Siegen (119.50€) and in North-Rhine Westphalia (59.40€) plus the solidarity contribution (4€) adding up to **182.90 €** for the upcoming semester. You will be receive back your special contribution to refinance the refunding ("Soli-Euro") included in the semester fee. It is stated in the "special hardships regulation" (Härtefallordnung¹, HärtefO) who is entitled to receive the refunding and how the process works. In cases of doubt a committee (so called Härtefallausschuss) elected by the students-parliament decides.

Reasons for application may be: *Handicap*:

Handicapped people may use public transportation free of charge so they can apply for refunding of the Mobilitätsbeitrag (mobility fee).

***Special hardship (Härtefall)*:**

As special hardship count:

- Students with children
- Non-German students with limited permission to work
- Students with a difficult financial situation

Legal basis:

Legal basis are the contribution regulation (Beitragsordnung) of the students body as well as the regulation for refunding of the mobility fee (Ordnung zum Erlass des Mobilitätsbeitrages) according to §2 Abs. 3 of the contribution regulation.
