## Reasons for application may be:

#### Handicap:

Handicapped people may use public transportation free of charge so they can apply for refunding of the Mobilitätsbeitrag (mobility fee).

## Special hardship (Härtefall):

As special hardship count:

- > Students with children
- > Non-German students with limited permission to work
- > Students with a difficult financial situation

#### Legal basis:

Legal basis are the contribution regulation (Beitragsordnung) of the students body as well as the regulation for refunding of the mobility fee (Ordnung zum Erlass des Mobilitätsbeitrages) according to §2 Abs. 3 of the contribution regulation.
