3. Right to Vote and Eligibility for Election

a) for Studentparlament

- I. All members of the student body of the University of Siegen who have been enrolled since May 1, 2025, and are listed in the electoral register are eligible to vote and to be elected (§ 3 Abs. 1 WahIO VS). A person is considered a member of the student body if they are properly enrolled.
- II. Guest students and secondary enrollees are neither eligible to vote nor to be elected (§ 3 Abs. 2 WahIO VS).
- III. Students on a leave of absence are eligible to vote and to be elected (§ 3 Abs. 3 WahIO VS).

b) For councils of the Department

- I. All members of the student body of the University of Siegen who belong to the respective faculty, have been enrolled since May 1, 2025, and are listed in the electoral register are eligible to vote and to be elected within their respective student council (§ 3 Abs. 1 WahIO VS). A person is considered a member of the student body if they are properly enrolled..
- II. Guest students and secondary enrollees are neither eligible to vote nor to be elected (§ 3 Abs. 2 WahIO VS).
- III. Students on a leave of absence are eligible to vote and to be elected (§ 3 Abs. 3 WahIO VS)

4. Election nominations

a) for Studentparlament

- I. Election nominations must be submitted in writing to the election committee at the AStA office (AR-H 105) by June 2, 2025. If submitted electronically in advance via email to the election committee (wahlausschuss@asta.uni-siegen.de), the original forms must be handed in within 5 days. The election committee provides the necessary forms on the AStA website.

- II. The election nomination must include the name of the list, contact details of the responsible person, name, student ID number, and faculty of the candidate, as well as the designation of the body to be elected (§ 8 Abs. 2 WahlO VS).
- III. The election nomination must be accompanied by the candidate's written declaration of consent and their full address, including email address (§ 8 Abs. 3 WahlO VS).

b) for councils of the department

- I. Election nominations must be submitted in writing to the election committee at the AStA office (AR-H 105) by June 2, 2025. If submitted electronically in advance via email to the election committee (wahlausschuss@asta.uni-siegen.de), the original forms must be handed in within 5 days. The election committee provides the necessary forms on the AStA website."

- II. The election nomination must include the name of the list, contact details of the responsible person, name, student ID number, and faculty of the candidate, as well as the designation of the body to be elected (§ 8 Abs. 2 WahlO VS).
- III. The election nomination must be accompanied by the candidate's written declaration of consent and their full address, including email address (§ 8 Abs. 3 WahlO VS)

The submitted election nominations will be publicly posted within the university after the deadline, but no later than June 9, 2025, and will remain posted until the end of the election.

Objections to typographical errors within the election nominations may be submitted to the election management until June 16, 2025. The objection must be submitted in writing or electronically via e-mail (§ 9 Abs. 3 WahlO VS).

5. Number of members to be elected

a) Studentparlament has 25 Members (§ 21 WahlO VS).

b) Unless a different number is stipulated in the respective student council statutes, the number of mandates to be allocated is seven (§ 26 WahlO VS).

6. Elektoral system

a) For Studentparlament

- I. For the election, the entire student body of the University of Siegen constitutes a single electoral district (§ 22 Abs. 1 WahlO VS).
- II. The election is conducted based on electoral lists (§ 2 Abs. 2 WahlO VS). Each voter has a total of three votes, which may be distributed among the lists themselves or among candidates from one or more lists (§ 22 Abs. 2 Satz 1 und 2 WahlO VS).
- III. Cumulative voting is permitted (§22 Abs. 2 Satz 4 WahlO VS).
- IV. Each voter has the option to abstain from voting (§ 22 Abs. 2 Satz 3 WahlO VS).

b) for councils of the department

- I. Each student council constitutes an electoral district for the election (§ 27 Abs. 1 WahlO VS).
- II. International students participating in the German language course vote within their respective academic department.
- III. The election is conducted based on electoral lists (§ 2 Abs. 2 WahlO VS). Each voter has a total of one vote (§ 27 Abs. 2 WahlO VS).
- IV. Each voter has the option to abstain from voting (§ 27 Abs. 2 WahlO VS).

7. Electoral register

The electoral register can be inspected at the AStA office during office hours, starting no later than May 23, 2025. Objections to errors in the electoral register may be submitted to the election management until June 2, 2025. The objection must be submitted in writing. The election committee will decide on the objection by June 7, 2025.

8. Postal voting

The option of postal voting is available (§ 11 Abs. 1 WahlO VS).

Postal voting must be requested no later than June 20, 2025, either in writing with a personally signed document or in person from the election management. A valid student ID must be presented when applying for postal voting. The postal voting documents will then be sent to the voter, but may also be collected in person at the AStA office (AR H 105) Please note that Deutsche Post has extended its delivery guarantee from 3 to 4 working days. As a result, it is possible that even postal ballots requested on time may not be delivered in time. However, for voters who apply for postal voting by June 16, 2025, it can be guaranteed that the voting documents will be sent out in time
